STATEMENT OF SAN ANTONIO FAMILY ASSOCIATION

Planned Parenthood has killed the innocent unborn for decades under the guise of *legalized choice* and it wants to keep this legal permission to kill unfettered by any regulation or opposition.

Previously, it deceived the citizens of Aurora, Illinois by using a front company to construct a 21,000-square foot killing facility in violation of Aurora's zoning regulations. The citizens of Aurora have won an Illinois appellate decision that will allow a subordinate court to determine the extent of zoning violations in Aurora. Planned Parenthood used a similar deception tactic in San Antonio, Texas by using a front company to obtain property in order to turn it into a killing facility at 2140 Babcock. Nationally, Planned Parenthood has bartered in human body parts and tailored its killing method of babies to maximize its procurement of undamaged human body parts.

In all of this, Planned Parenthood continues its *modus operandi* of deceiving the public where it can and bullying those critics who catch Planned Parenthood lying. The San Antonio Family Association will not be bullied by killer organizations and those who lie for them.

On December 2, 2005, Planned Parenthood's spokesperson, Mara Posada, issued a statement published by the San Antonio Express-News wherein both the Express-News and Planned Parenthood conveyed: "Extremist groups like the San Antonio Family Association, who are against even birth control, oppose all our health centers, no matter where they are located."

Everyone knows that the term *extremist* is intended to connote something other than opposition to birth control. Planned Parenthood's expertise in parsing and use of connotation is well-known to governmental regulators. Regardless, we can take the Express-News' publication of Planned Parenthood's statement in a literal sense merely to determine whom else Planned Parenthood considers as an *extremist*. Since Planned Parenthood's statement establishes the criterion for *extremism* as opposition to birth control, then those who would seem to oppose birth control would be *extremists* according to Planned Parenthood. Under this logical connect-the-dots process, everyone now can discern that Planned Parenthood likely considers the Catholic Pope, the San Antonio Catholic Archbishop, and the Roman Catholic Church to be *extremists*. For good measure, Planned Parenthood might even add a few orthodox Christian congregations to its claim of *extremism*.

Only in the proverbial out-of-touch mind of a killing organization like Planned Parenthood could that mind ever believe that its statement of December 2nd is an effective public relations strategy. Calling Roman Catholics and people of Faith *extremist* is a poor public relations debacle that only will compound the belief of a majority of Texans that Planned Parenthood needs to be defunded and that abortion needs to be more rare than Planned Parenthood would like.

In a similar move, Planned Parenthood employed the law firm of Strasburger & Price to write a letter to the Texas Attorney General on July 24, 2015. In that letter, the Strasburger firm sought to convince the Texas Attorney General that zoning information sought by the San Antonio Family Association from the City of San Antonio regarding 2140 Babcock should not be released. One of Strasburger's arguments was to equate the San Antonio Family Association with terrorism based upon the United States Department of Justice's website advisories that domestic terroristic threats could come from pro-lifers. The Texas Attorney General ultimately based his decision on the likelihood of additional litigation between the San Antonio Family Association and others—not on the silly and improper statements of Strasburger & Price.

Regardless, one of the Strasburger attorneys who has also represented Planned Parenthood is Mr. Mark Sessions—son of former FBI Director William Sessions. Whether witting or unwitting—Mark Sessions' law firm served as an accomplice in Planned Parenthood's *modus operandi* when Strasburger took the low road its client took many times before. If Strasburger truly believes that whatever the Department of Justice writes must be true then, logically, it would have to believe that former FBI Director William Sessions is a tax cheat, and an abuser of power and office because the Department of Justice's Office of Professional Responsibility determined that conduct in a report dated January 12, 1993. In a rather ironic juxtaposition of persona, that report ultimately led President Bill Clinton to fire Director William Sessions.

The San Antonio Family Association will continue to speak truth to power in defense of the family and the unborn. We have always been and will always be respectful of people and polite; yet, candid.
