**PRO-LIFE MUSTER AND PRESS CONFERENCE AT 4:45 PM June 27, 2016 AT 4025 E. SOUTHCROSS, SAN ANTONIO, TX 78222 IN FRONT OF WHOLE WOMAN'S CHOICE ABORTION FACILITY**

Today the San Antonio Family Association will hold a press conference and Pro-Life Rally in response to the Supreme Court of the United States (SCOTUS) decision to overturn the Texas House Bill 2 (HB2, 2013) law.

The 5-3 SCOTUS decision on HB2 actually puts women at physical risk in abortion facilities. The standard of care for women in abortuaries will now be reduced to the standard of care of a nail salon as it was prior to 2013.

Some progressives will argue that women's rights to choose to terminate the baby growing inside her exceeds that of the quality of the care that a woman will received by paying an abortionist to kill the unborn baby in her womb. Women are already at great risk in a surgical abortion as the abortion provider stops the natural progression of a pregnancy. This SCOTUS decision now gives license to pregnancy chasers, sex traffickers and predators to target women in crisis situations.

This situation has less to do with the aborted child and he/she has already been killed. It has everything to do with saving the former mom's life in the fairly common occurrence of a perforated uterus, excessive bleeding, hemorrhages or even heart attacks while the woman is on the table.

For comparison, the health standard requirement for Liposuction will now far exceed the health standard requirements for a Suction Abortion (also known as a D&C Surgery) after today.

It's important to remember that HB2 dealt with hospital admitting privileges by the abortionist, health standards like proper sanitation, Proper medical staff to care for patient, ten foot hallways, sterilization of equipment and accounting for and disposal of aborted babies body parts.

Therefore, this exposes the phony war on women to really be a war to protect big abortion businesses. This imprudent SCOTUS decision exposes a purely ideological decision based on disordered passions not on principles and certainly not on good healthcare standards for women.

Locally in the City of San Antonio, fortunately, the CoSA City Council passed an Ordinance last year on December 17<sup>th</sup> that protects residential neighborhoods from the construction of any new abortion facilities and Ambulatory Surgical Centers as they are all defined as medical 'clinics'.

This creates a new need for prudent laws that require hospitals to report complications from abortion surgeries that lead to women's deaths due to botched abortions.
