This morning the San Antonio City Council is deliberating two Agenda items that can harm our City's youth.

Item #15 authorizes the local health department to apply for and receive a federal grant worth a half million tax dollars to essentially tell our teenagers that they are mere animals unable to control themselves so the City is providing you another vaccine to fight another sexually transmitted disease causing cervical cancer. Moreover, the HPV Vaccination is dangerous. During Gov. Rick Perry's administration, HPV Vaccine Gardasil came under intense scrutiny when an attempt was made to use the vaccine on female teen immigrants. Due to the dangerous nature of the vaccine to teen girls, the initiative was withdrawn. It is important to remember that the HPV Vaccine is dangerous and has resulted in thousands of girls having adverse reactions to the HPV Vaccines with over one hundred lives having been lost.

Will parents be properly educated and informed on the dangers of this vaccine and non-marital sexual activity?

Item #31 also promotes promiscuous ideas under an agreement between the UTSA Health Science Center and SAMHD to participate in evidence-based Teen Pregnancy Prevention education programs. While it's only \$12,000, the premise is that we have to find out if Sexual Risk Reduction experimentation programs work to help curb sexual activity amongst the City's youth. The idea that evidence needs to be created to see if the "abstinence-plus contraception-based sexual education curriculum" works is duplicitous and fails in comparison to abstinence-only or Sexual Risk Avoidance programs. Additionally, why is the Council voting on a proposal that has already begun and will have to be made retroactively?

It is troubling that the supporting documents of these Agenda Items do not give exact detail on the harmfulness of the HPV Vaccines and the curriculum that the evidence collected will be based on for full disclosure to the Council and the public. Further disturbing is that the Metropolitan Health District Medical Director, abortionist Chichi Junda Woo, former Medical Director of 'Planned Parenthood South Texas' will continue to serve as an instrumental part of the City's participation in drug-based contraception that can cause chemical abortions killing a conceived child and harming the Teen mother. The City Council is again placed in the precarious position of having to ratify our local health department's quiet formulation of another harmful program and have to do it retroactively.

Evidence proves time and again that abstinence is the most effective way to help our City's youth remain healthy. It is possible. Just as you sit in Council Chambers currently remaining abstinent and under self-control, the youth of our City can learn to exercise self-control, self-restraint and responsibility with your help and encouragement towards chastity to enjoy genuine good health. It would be better to apply for a grant that would teach San Antonio Teens chastity awareness.

Continuing to promote permissiveness and condone non-marital sex is both dangerous and demeaning to the youth of San Antonio and disrespectful to tax payers. Parents need to know that they can trust civic government however promoting promiscuity betrays that trust. Please consider voting against these harmful programs to save our youth.
